very nostalgic path, thinking about our family's history with Registered Holsteins®, which dates back to 1904 when my great-grandparents on my mom's side brought the first Registered Holsteins into Oregon. We had outstanding attendance at last year's Junior Holstein Convention and awarded the first George Miller Memorial Scholarship to Kylie Konyn, CA. We look forward to 2024, with another virtual Spring Into Action Seminar and over 70 participants meeting in Tampa to kick-off YDLI Class 13.

A member of the original YDLI Advisory Committee in 1992, Diedra (Johnson) Harkenrider, joined the Holstein Foundation team in June 2023 as the director of development. I'm proud of the staff that carry out Foundation programs with enthusiasm and the desire to grow activities, while keeping them relevant and inclusive to all. 
EDUCATIONAL WORKBOOKS
